Highlights for Fiscal Year April 1, 2014 – March 31, 2015

Counseling Hours: Over 22,000 hours of counseling were provided in 22 locations. Of these hours, 677 were provided through our Low Fee Clinic at fees under \$21 per session/hour. In total, we provided \$767,870 in uncompensated care.

Commitment to Diversity: Samaritan therapists have the ability to provide counseling in Spanish, German, Cantonese, Mandarin and several of the many languages spoken in the Philippines as well as in English. We welcome people of all faiths, backgrounds and lifestyles.

New Staff: Joining our staff of 30 state-licensed therapists was John Baumann, M.Div., LMHC, Caren Osborn, MA, LMFT and Courtney Paine, MA, LICSW.

New Board Members: Marcia Riggers from St. Andrew's Lutheran Church in Bellevue, and Rev. Eliana Maxim from the Presbytery of Seattle.

Staff Development and Consultation: Psychiatric Consultant Dr. David Harrison, Assistant Professor in the Department of Psychiatry & Behavioral Sciences at the UW School of Medicine, meets monthly with our clinical staff. His interest and experience in the integration of spirituality and mental health make this particularly beneficial for our staff.

Other regularly scheduled Clinical Enhancement activities include monthly Continuing Education presentations and Peer Consultation Groups.

Fund Development:

- Due to your generous donations, our **2014 Spring Luncheon and Auction** raised \$50,000 for the Samaritan Fund which enables us to provide counseling for those without sufficient financial resources.
- **United Way** renewed their support of \$47,500 for the CareTeams Program which supports those living with HIV/AIDS so they may remain in their homes.
- **Stewardship Foundation** awarded a grant of \$45,809.
- **Employees Community Fund of Boeing Puget Sound** awarded a grant of \$34,900 which enabled us to complete the second phase of the Ravenna Chapel renovation. This phase of the project included sound, projection, lighting, and acoustics, and was completed in December, 2014.

Sharing Our Space: We continue our intentional sharing of space with others who serve the community, including Children of the Nations and a number of 12-Step programs.
